Q1. Since HCC does not own the compactors do we build the rental charge into the price per month or can this build billed separately?

Response: Please price separately. Exhibit No. 1, Scheduled Items and Prices, dated 6/18/21 is hereby revised.

Q2. Does this bid allow for installation for (2) compactors?

Response: Yes, one to be installed at the Hayes Rd location and one at the Administration Building location.

Q3. The bid mentions that some locations might need slant dumpster. Do you know how many slant dumpsters might be needed?

Response: At the least 7 slant units.

- Q4. In Tab 3 Proposed Approach & Methodology, section i., on page 38, the requirement states, "Proposer shall respond to all requirements and questions noted in Section 1". Which section one (1) does this requirement reference. I have identified three possibilities below.
 - 1. Section 1 of Attachment No 2, p. 28
 - 2. Section 1 of Attachment No 7, p. 40
 - 3. Section 1 Project Overview & Scope of Services, p. 3 (no questions cited here)

Response: Section 1 – Project Overview & Scope of Services, beginning on Page No. 3.

Q5. Regarding the General Instructions, Tab 3, Section IV, p. 18. Is this the appropriate place to include a description of our "Value Add Services" that are not called for in the RFP documents?

Response: Yes, Proposed Approach & Methodology.

Q6. Does section 2.2 - Requirements, Bullet 3, p.6 - refer to Landfill and Materials Recovery Facilities (MRFs)?

Response: Yes.

Q7. Regarding the Questionnaire document that is located on p. 15 of 54? Is this intended to be a separate document that we would include in our response or should responses to the Questionnaire only be included within the indicated tabs as referenced? Note, letter "e", Past Performance and Work does not reference a tab. Please advise?

Response: Yes, please respond in the appropriate tab identified. Past Performance & References is Tab 4

Q8. Will the requirement listed under Section 2.3 Regulatory Compliance, Recycling & Single Stream Recycling, Plastics p. 6, be satisfied by including a listing of acceptable and unacceptable single streamrecyclable items within the proposal document and tab referenced for this section?

Response: Vendor must be able to accept and haul off items as listed, but not limited to.

Q9. Regarding Section 2.0 Scope of Services, 2.4 Requirements, p. 7: How many days does HCC estimate it will require the Contractor to furnish and deliver containers to all HCC locations following a fully executed Agreement? It is unclear whether the written "Notice-to-Proceed" precedes or proceeds any fully executed Agreement between the Contractor and HCC.

Response: The Notice to Proceed, commonly is issued after the contract/agreement has been executed. On occasion, the Notice to Proceed, can be issued after Board of Trustees approval, in-lieu of a pending executed agreement.

 - 1. Should the following locations include days of service listed based on the information included in the document, Exhibit 1 SCHEDULE OF ITEMS AND PRICING:
 - a. Spring Branch, 1010 West Sam Houston Pkwy, (Parking Lot Enclosure) no recycle daysof services provided.
 - b. Campus Parking Lot, 6815 Rustic St., Houston, TX 77087 no recycle days of services provided.
 - c. JB Whitely Building, 1301 Alabama, (Parking Lot Enclosure) no waste days of services provided.
